Bundle Workgroup Activity for 9/24 Meeting

- Provide directions on what we expect during meeting.
- Goal is to have the groups work on identifying funding opportunities and to define who is the main coordinator for each workplan.
- Have groups start documenting projects.
- Alyssa and Tyler will look for bundle workgroup leaders from GSI files.
- Alyssa will print the bundle workplan for the meeting.
- Billie Jo is the lead for the LCWSA don't have anyone helping me (David, but not attending). She will
 commit to writing some type of update about their project and progress.
- Make sure we have a note-taker for each workgroup.
- When we adjourn the regular meeting, invite others to stay and join a bundle workgroup discussion, even if it's just to listen and learn.

Web Connections Activity for 9/24 Meeting

- On a large poster sheet, participants jot down their project and connect each to funding, technical
 assistance, and organizations that can support the project in various ways. This activity has been
 done with NRCS projects focused on conservation and it worked well.
- Should we group tables by sector? Committee recommended mixing sectors.
- Put partnership at the center of the poster sheet how can the Partnership support each project?
- Expect about twenty people in person attending.
- Katie from Lincoln SWCD can help moderate an online session for this activity, if enough people join.
- Decided since there isn't sufficient time to report out, we'll collect posters and write a short synopsis.

Drought Update Discussion

- Discussed whether to keep the drought discussion or replace it with the Web Connections activity, noting that there isn't sufficient time to do both items.
- A few thought that having drought on the agenda will bring people to the meeting and it's been on the minds of many this year.
- Use this topic to encourage partners to report drought impacts to the USDA's Conditions Monitoring Report.
- Action Item: Alyssa and Tyler will chat after this meeting to discuss weaving drought into the Web Connections activity.

Roundtable Updates

- Lincoln SWCD Kayak Series River Floats Tyler mentioned the recent float on the Salmon River.
 Kayakers started at the ODFW hatchery, which is slated for closure, with 12 boaters on the water.
 The timing was great we saw many chinook salmon during the event. We floated downstream four miles and it took about three hours.
- Steve The Integrated Water Resources Strategy (IWRS) will be before the Water Resources
 Commission for adoption today, 9/11. Next steps include workplan development to better support
 implementation. ODFW recently hired Emily-Bell Dinan to help with water planning. Oregon DEQ has
 hired its fourth IWRS position, located on the east side of the state. Steve also noted that the Oregon
 Department of Agriculture has hired Nick Sirovatka, who will be involved in IWRS work, including
 place-based integrated water resources planning.
- Billie Jo Lincoln County Water Systems Alliance is hosting an in-person meeting at the end of
 October, inviting leaders from tribes, cities, and county. Alliance members continue to work through
 the governance structure.

Meeting Wrap Up & Next Steps

• Discussed having Alyssa continue supporting for the coordinating committee or whether others may want to take on this role. Committee agreed that if would be helpful if Alyssa continued helping, allowing Tyler the time and capacity to tackle other projects under the Roundhouse grant.
