Agenda & Meeting Notes Review

Committee reviewed the 7/10/2025 Meeting Notes. No changes suggested.

General Updates

- Alyssa noted that she heard a <u>coastal-focused water conservation outreach message on KGW News</u> and was really impressed with the local articles and ongoing campaign to conserve water.
- The Siletz River is on track for being the lowest flow ever recorded, possibly worse than 2015.
- The Mid-Coast Water Conservation Consortium is doing a lot of the targeted outreach, sharing not only water conservation tips, but also the importance and value of water. The Consortium targeted various sectors: commercial and industrial sectors, vacation rentals, with specialized flyers and information that can be posted at bed and breakfast locations, online rentals, or hotels. Those efforts have been effective, with several calls coming and folks using the website and information.

Draft Flyer Edits

• The Committee reviewed a draft flyer to advertise the 9/24 Partnership meeting. Minor edits were suggested and sent along to Tyler.

 participate and partner with David on a few slides showing hydrographs and how climate change will
 exacerbate these conditions, with the goal to remind people about climate change impacts on the
 region and set the stage for the drought-themed community connections/web activity. Action Item:
 Alyssa will connect with Nikki.
- Funding Workgroup during updates, Steve can make a call for more members to join the Funding Bundle workgroup, which will be needed to help prepare a grant application for OWRD's solicitation this Fall.
- Legislative Update During meeting, Steve confirmed that Harmony Burright is available provide a 2025 Legislative Update and 30 minutes should be sufficient.
- Room Set-Up Billie Jo volunteered, but another person or two would be helpful. David could be backup if we lack volunteers.
- Room Clean-Up Billie Jo, Steve, and Alyssa volunteered.
- Transportation likely won't have rented vehicles for transportation. Possibility of using Newport's vehicles if we coordinate early. Seal Rock also has a few vehicles.
