CALL TO ACTION

“Oregon water management is at a [critical] tipping point necessitating decisive action and adaptation”

- An appeal to modernize Oregon's water laws from prominent water law experts (2024)

WHY NOW?

Large Demand for Limited Supply: Surface and groundwater are fully or over-appropriated across much of Oregon, requiring adaptation.

Serious Threats to Health and Safety: Communities across Oregon are dealing with aging and failing water infrastructure.

Complex and Persistent Challenges: Long-standing water resource challenges require sustained attention, leadership, and investment.

Shifting from Reactive to Proactive: A transition is needed from crisis-driven responses to proactive approaches that reduce long-term costs.

GENERATING SOLUTIONS

Build on Past Success and Lessons: Review policies and investments from the past to inform decisions and improve outcomes for the future.

Respond to Urgent Issues: Stay alert to urgent issues affecting the state and communities, including ongoing media coverage.

Address Long-Standing Needs: Review plans, studies, and reports to identify issues and needs that have previously been identified.

Engage and Partner: Engage with colleagues, agencies, tribes, advocates, subject matter experts, and communities.

PRIORITY AREAS

- Safe and Reliable Drinking Water
- Better Sharing of a Scarce Resource
- Informed Water Management
- Efficient and Equitable Processes
- Strategic Water Investments

SAFE AND RELIABLE DRINKING WATER

Groundwater Quality Protection: Modernizing the Groundwater Quality Act for more proactive management to address water quality.

Drinking Water Infrastructure: Supporting critical drinking water projects, often identified as a top priority, including to meet housing production goals.

Small Community Water Systems: Continuing to assess and address vulnerabilities of small community water systems.

Emergency Assistance: Responding to water crises, domestic well and septic system issues, and exploring safety net for vulnerable ratepayers.

BETTER SHARING OF A SCARCE RESOURCE

Water Reuse: Overcoming barriers to water reuse projects, including establishing an interagency water reuse program team.

Aquifer Recharge: Continuing to address barriers, develop technical assistance, and advance aquifer recharge and storage in Oregon.

Water Banking: Exploring statewide and region-specific authority to address water supply shortfalls with flexibility and accountability.

Conservation and Efficiency: Incentivizing water conservation and efficient use across multiple sectors.

INFORMED WATER MANAGEMENT

Groundwater Sustainability Scorecard: Using data to prioritize management actions and help communities achieve sustainability.

Integrated Water Data Portal: Advancing development of a water data portal that will increase accessibility and usability of water data.

Data Gathering: Strengthening OWRD authority to obtain water use data and investing in monitoring of water supply, quality, and habitat.

Updated Basin Assessments: Ensuring technical basis necessary to understand and meet instream and out-of-stream water needs.

EFFICIENT AND EQUITABLE PROCESSES

Contested Case Backlog: Refining OWRD and Office of Administrative Hearings contested case processes to address and prevent backlogs.

General Process Improvements: Considering statutory and administrative changes that improve efficiency and equity of OWRD processes.

Transfer Processes: Exploring opportunities to increase timeliness and flexibility of transfers while accounting for resource impacts.

Reliability: Protecting existing water users by proactively limiting additional approvals in fully appropriated and over-appropriated areas.

STRATEGIC WATER INVESTMENTS

Improvements to Existing Programs: Identifying and implementing improvements to OWRD's existing funding programs.

Water Equity Investments: Continuing investments to support water equity work within communities across Oregon.

Infrastructure Funding Strategy: Advancing a more cohesive, strategic approach to statewide water infrastructure investments.

Federal Funding Readiness: Expanding capacity to track, coordinate, and offer technical assistance on federal funding opportunities.

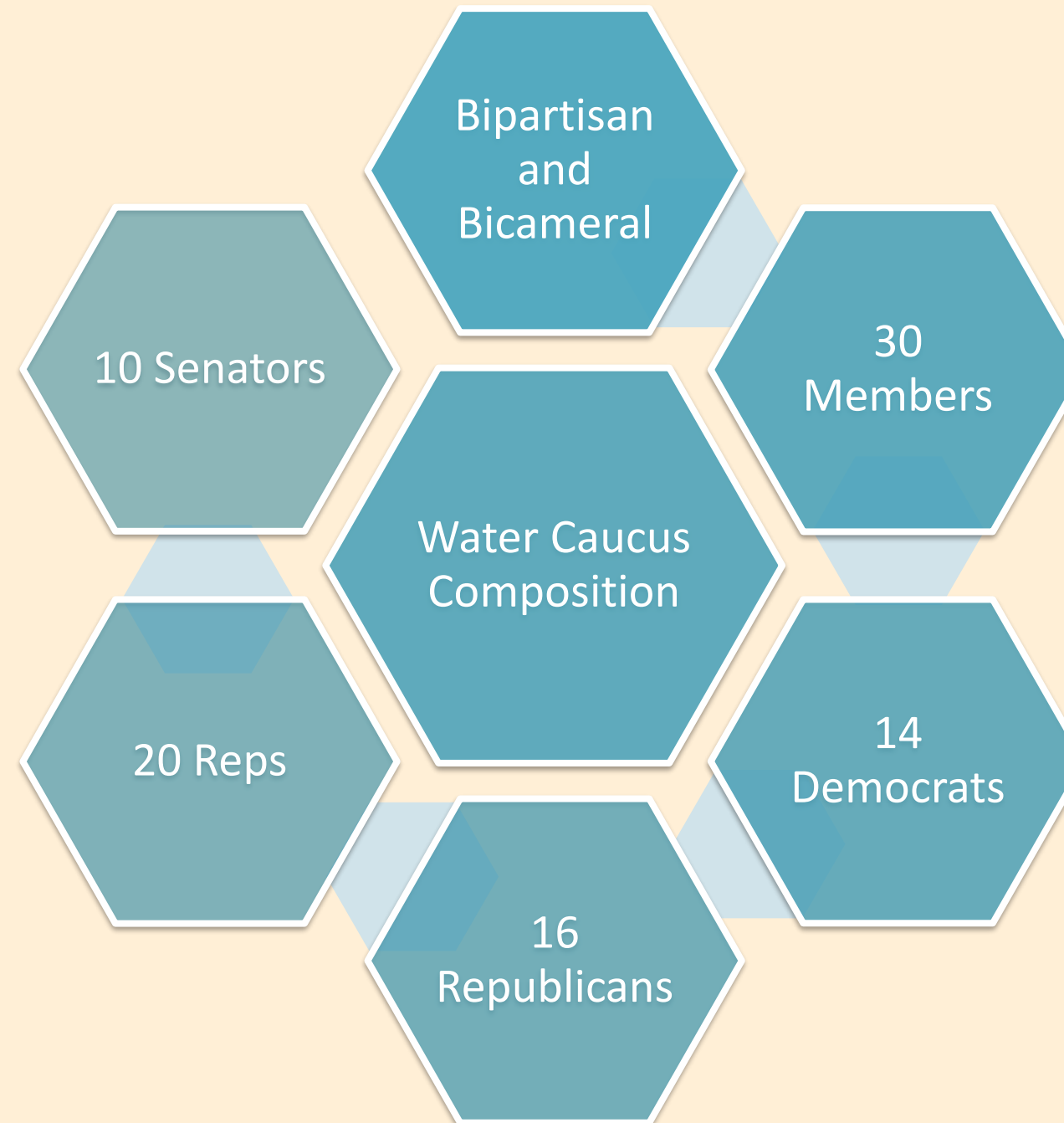

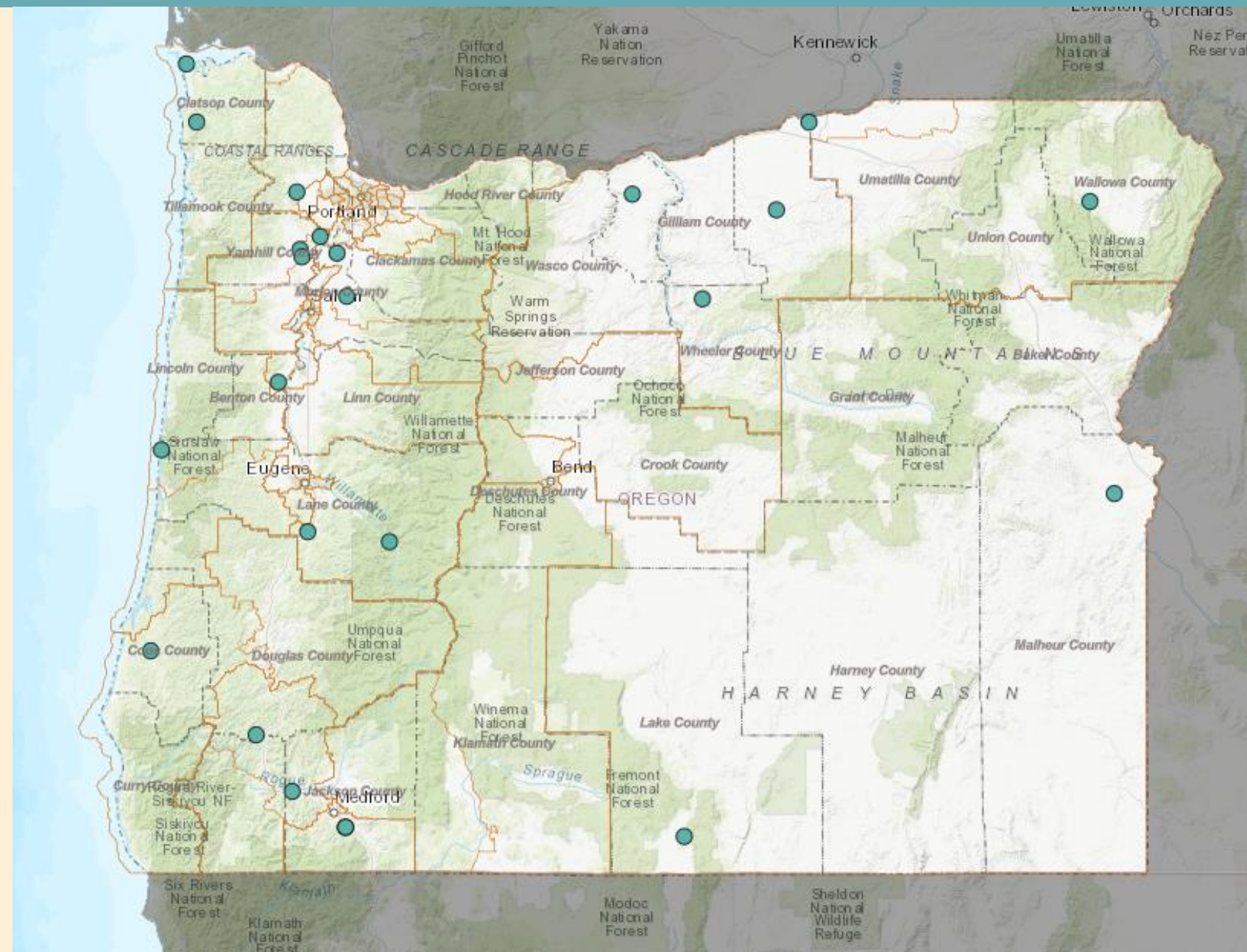
Tackling complex water challenges requires focused leadership, innovation, and long-term commitment to learning and working together.
